RE: Confidentiality

I believe the public is unaware of who exactly is in their "circle of care". Until/unless the members of the circle of care are clearly specified, I believe the restrictions for consent to release of information *in writing* should REMAIN. If there are differences between the Colleges, the other Colleges should be upgraded to this standard, rather than CRPO's standard downgraded. Once the "circle of care" has been identified in writing to the client, then further consent would only need to be verbal.

Mental health care has a stigma like no other condition, with potential for severe work/career and/or parenting implications. This needs to be acknowledged in how records are kept confidential. As it stands now, I've been informed by a few hospital employees that they will NOT get mental health care from any hospital provided outpatient program (e.g., mood and anxiety group) because they are concerned about confidentiality issues and career restrictions. It has been reported to me that ANY hospital employee can access all the records of any patient in the system (though they've also stated that "we're not supposed to"). The fact that they *can* is an issue, and should be addressed through at least password protection that only the members of the circle of care would have access to.
