This has always been concerning as we don't always have information of contact information of the possible intended victim - but with modern technology it could be argued we could go about finding contact information (direct messaging on social media, etc). Is there any more clarity that can be provided on what is a reasonable expectation of this legal requirement to inform the intended victim vs just police?

Also - for clients that regularly discuss and talk about suicide, with plans and access and means and even a date - but this is their regular state as well - what guidelines can be provided to help navigate this? Some clients would be sent to hospital or called police every session if these guidelines in this draft are followed to the letter.

I would also love some written guidelines for intoxicated clients or clients that disclose they drink and drive or smoke weed and drive etc. I have guidelines I work by already but would find it helpful for the CRPO to outline these as well.
