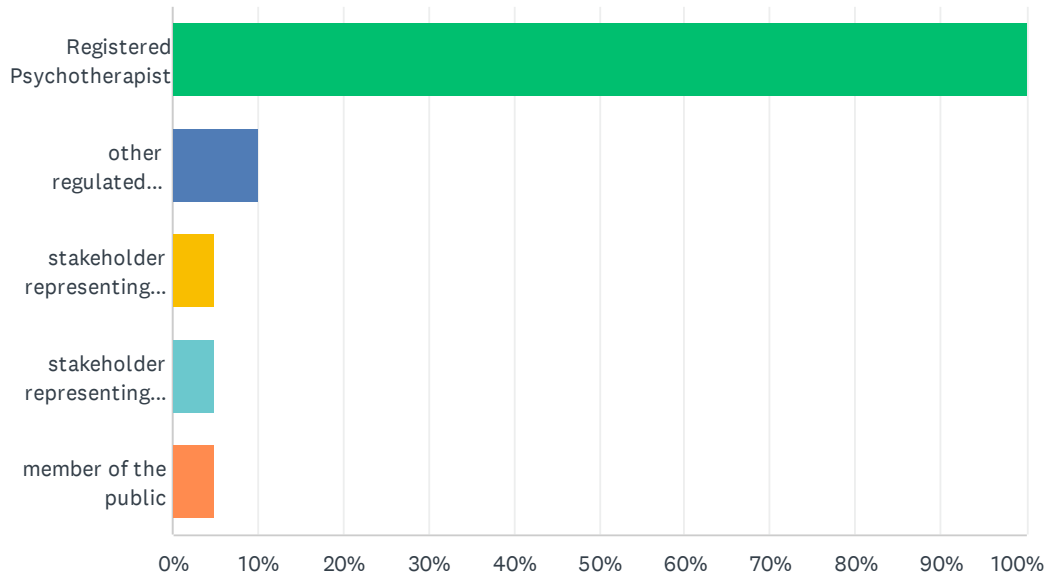

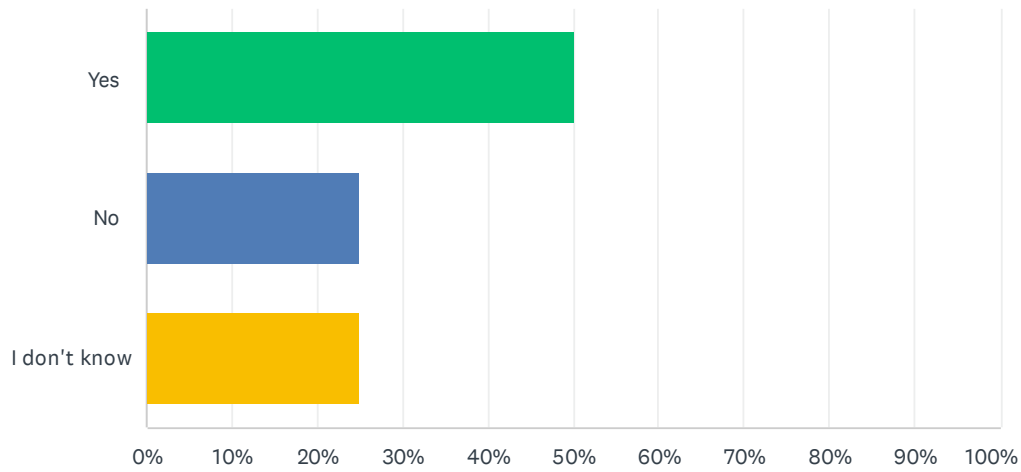

1	I understand the requirement of including a clinical placement as a requirement for the training institute to support students in finding such a placement or, better still, offering such a placement as part of the training. Currently, most training institutions leave it up to the students to find their placements which - in the current climate - is very hard indeed. Most clinics do still prefer psychologists or social workers to psychotherapists (or simply don't have an RP on staff for supervision); and private practice RPs often don't have the capacity to carry interns.	7/25/2020 8:08 PM
2	Program requirement should be much longer than six months minimum. If a program is only six months in length there is no room to meet other requirements such as hours of client contact, course work, and supervision.	7/23/2020 4:54 PM
3	I have some concerns with the discrepancies between what is required of new therapists entering the profession and that which was required of those who were grandfathered in. If the role of CRPO is to protect the public, more should be done from that standpoint to ensure that older therapists (those of us who have been practicing for longer) are able to meet the same ethical competencies that are being required of new therapists. This should be uniform across the board. I have heard from too many young therapists about supervisors, (as most who are able to be supervisors are those who were grandfathered in), who have been practicing for years yes, however are unable to answer questions that are related to simple ethical dilemmas by CRPO standards. 4	I believe it is essential to periodically review the training programs and their requirements to address gaps. 5	Unsure that broadening of education degree requirements is appropriate to include bachelor's degree as the minimum requirement. Already I have seen fairly relaxed requirements from the college, including registrants that do not have formal post secondary education in psychotherapy. Please reconsider this item, as I think it becomes increasingly difficult to verify the educational history when opening up your definition to be so broad. Like I said previously, I know of someone registered who doesn't even have a BA, in fact the greatest education of this individual is a college diploma in police foundations. Furthermore, I find the document itself to be unclear and somewhat confusing. Is the requirement that applicants must have a masters degree? If so, then why does the document refer to diplomas and certificates?
