



95	I support the creation of an Emergency Class registration path, however I think the fee should be lower than for Qualifying registrants (ideally no fee at all) and that the CRPO should undertake additional measures to smooth all logistical hurdles. I am a humanitarian mental health specialist and thus am familiar with the settings in which a psychotherapist might propose servies to respond to urgent and severe mental health needs. Under such conditions there are innumerable logistical obstables to navigate, from visas to emergency housing, transport across disaster-affected areas, accessing utilities, ensuring that your presence is helpful without being a burden on a population affected by crisis, etc. These hurdles must all be jumped while the very regulatory bodies that would normally steer such logistics are themselves affected by the emergency, often operating at reduced capacity or unable to function at all. In a scenario where Emergency Class psychotherapists are truly needed (which, granted, is fairly unlikely), CRPO itself may not be functioning sufficiently well to facilitate registration due to loss of life among staff, illness, lack of access to internet, or other circumstances associated with the emergency.
